ORDER APPROVING EXECUTRIX' FINAL ACCOUNT

2. That Ethel Blaer died testate, a resident of Lake County, Indiana on
the 7th day of April, 1979, and her last Will and Testament duly ad-
mitted to probate before this Court on the 20th day of April, 1979; that this
Court appointed EVELYN ZAGROVICH, as Executrix of the Last Will and
Testament of the decedent and letters Testamentary were issued to her on the
20th day of April, 1979. That she has continued to serve in such capacity
since said date.
3. That the matter and things set forth in said account and petitions are
true and that the said Executrix has accounted for all of the assets in

4. That more than five (5) months have elapsed since the date of the first
published notice to heirs, legatees, devisees and creditors of said
