to terminate on December 1, 1979.

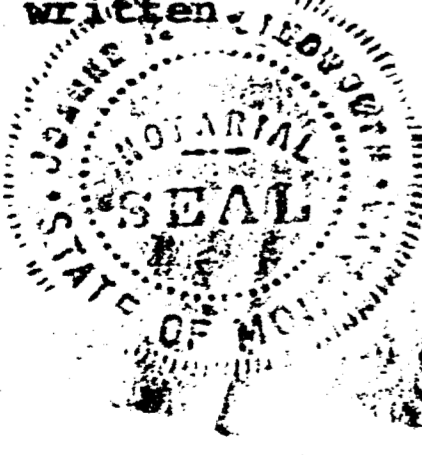
