ORDER APPROVING EXECUTOR'S
FINAL REPORT AND ACCOUNTING, PETITION
TO ALLOW ACCOUNTING AND PETITION FOR
ORDER APPROVING DISTRIBUTION AND CLOSING ESTATE

This cause came to be heard on the 16 day of November, 1979, upon the final account, petition to settle and allow account and for authority to distribute estate filed by Robert Earl Turman, as Executor of the estate of Mary Bridget McMahon, deceased, which account and petition are in the words and figures following, to-wit:

And it appearing that no objections were filed thereto and the Court being fully advised in the premises now finds that:

1. Due notices of the filing of said account and petition of the hearing on the same were given to all persons interested in said estate and the same are now properly before the Court for final action thereon.
2. That Mary Bridget McMahon, died testate, a resident of the County of Lake, State of Indiana, on the 12th day of August, 1978, and her Last Will and Testament was duly admitted to probate before this Court on the 1st day of November, 1978, and this Court appointed said Robert Earl Turman as Executor of the Last Will and Testament of the decedent, and said Executor was issued letters of testamentary on the 1st day of November, 1978, and since that date he has continued to serve in such capacity.
3. That the matters and things stated in said account and petition are true, and that said Executor has accounted for all the assets in said estate coming into his hands.
4. More than five (5) months have elapsed since the date of the first publication of the account and petition to the legatees, devisees and

creditors of said decedent; all claims filed against said estate have been discharged; neither said decedent nor her Executor were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. The following persons are the sole legatees and devisees under decedent's Last Will and Testament:

6. That the decedent owned a certain piece of real estate located at 1955 Union Street, Lake Station, in the County of Lake, State of Indiana, more particularly described as follows:

and that the decedent devised said real estate in Article III of her Last Will and Testament to Robert Earl Turman and Maureen Turman, and a copy of this decree showing the vesting of said real estate should be recorded in the Office of the County Recorder in which said real estate is located.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said Executor is hereby
in all things approved, settled and confirmed.

2. That the distribution of the balance of the property re-
maining in said Executor's hands for distribution has been made
pursuant to the distribution set forth in the final accounting
as prescribed under the Last Will and Testament of said decedent
and is hereby in all things approved.

3. That pursuant to the decedent's Last Will and Testament
the following described real estate, to-wit:

Lot 15, Block 1 in Schneider's 1st Subdivision in the Town
of East Gary, Lake County, Indiana.

is hereby vested in Robert Earl Turman and Maureen Turman, husband
and wife, pursuant to the provision of the decedent's Last Will
and Testament.

And that said Executor is hereby directed to procure and
record in the office of the Recorder of Lake County, being the
county in which said real estate is located, a certified copy of
this Final Decree.

4. Said Executor having made distribution of all assets and
property and having attached receipt evidencing said distribution
to said legatees and devisees, said distribution is hereby approved
and confirmed.

5. Said Executor is hereby released and discharged from any
further liability or responsibility as said Executor of the
estate of Mary Bridget McMahon. All of which is ordered this
