ORDER APPROVING EXECUTRIX'S FINAL REPORT
AND ACCOUNTING, PETITION TO ALLOW ACCOUNTING
AND PETITION FOR ORDER APPROVING DISTRIBUTION
AND CLOSING ESTATE

This cause came to be heard on the 9th day of APRIL,
1980, upon the final account, petition to settle and allow account
and for authority to distribute estate filed by Mary Elizabeth
Glueck, as executrix of the estate of Elwood D. Glueck, deceased,
which account and petition are in the words and figures following,
to-wit:

And it appearing that no objections were filed thereto and
the Court being fully advised in the premises now finds that:

1. Due notices of the filing of said account and petition
and of the hearing on the same were given to all persons inter-
ested in said estate, and the same are now properly before the
Court for final action thereon.
2. That Elwood D. Glueck, died testate, a resident of the
County of Lake, State of Indiana, on the 21st day of February,
1977, and his Last Will and Testament was duly admitted to probate
before this Court on the 30th day of March, 1977, and this Court
appointed said Mary Elizabeth Glueck as executrix of the Last Will
and Testament of the decedent, and said executrix was issued Let-
ters of Testamentary on the 30th day of March, 1977, to her, and
since that date she has continued to serve in such capacity.
3. That the matters and things stated in said account and
petition are true, and that said executrix has accounted for all
the assets in said estate coming into her hands.
4. More than five (5) months have elapsed since the date of
first published notice to legatees, devisees and creditors of said
decedent; all claims filed against said estate have been paid and
discharged; neither said decedent nor his executrix were employers
of labor within the meaning of that term as used in the Indiana
Employment Security Act; all estate taxes, inheritance taxes and
gross income taxes, if any, assessed in said estate have been
