ORDER APPROVING EXECUTRIX'S FINAL REPORT AND ACCOUNTING, PETITION TO ALLOW ACCOUNTING, AND PETITION FOR ORDER APPROVING DISTRIBUTION -. AND CLOSING ESTATE Clark Lake Count Count

This cause came to be heard on the 97% day of APRIL 1980, upon the final account, patition to settle and allow account and for authority to distribute estate filed by Mary Elizabeth Glueck, as executrix of the cutate of Elwood D. And it appearing that no objections were filed thereto and the Court being fully advised in the premises now finds that:

- l. Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.
- 2. That Elwood D. Glueck, died testate, a resident of the County of Lake, State of Indiana, on the 21st day of February, 3 1977, and his Last Will and Testament was duly admitted to grountebefore this Court on the 30th day of March, 1977, and this court appointed said Mary Elizabeth Glueck as executrix of the Last Wills and Testament of the decedent, and said executrix was issued Letters of Testamentary on the 30th day of March, 1977, to hear and since that date she has continued to serve in such capacity
