and State of INDIANA, to wit:

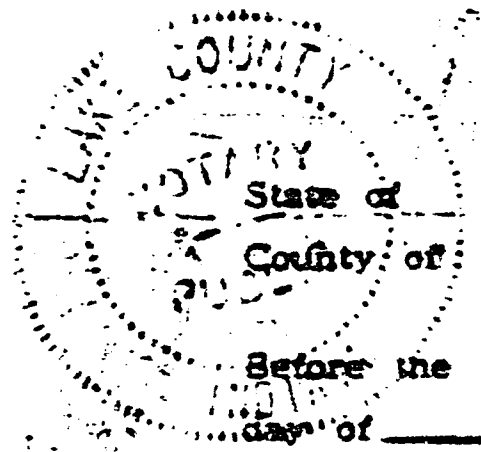
