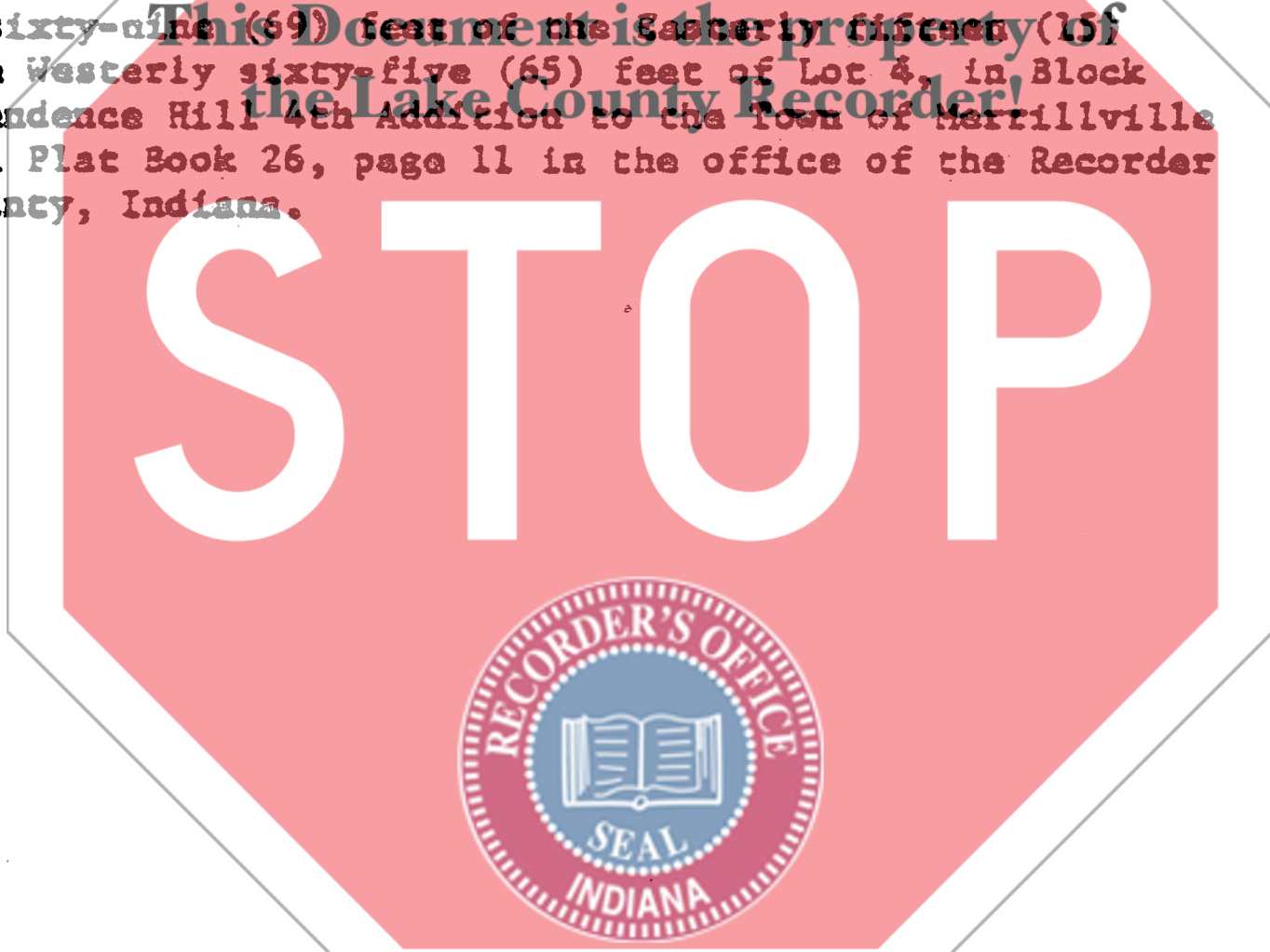

The North sixty-nine (69) feet of the Eastern boundary (15 feet of the westerly sixty-five (65) feet of Lot 4, in Block 2 in Independence Hill 4th Addition to the town of Merrillville as shown in Plat Book 26, page 11 in the office of the Recorder of Lake County, Indiana.



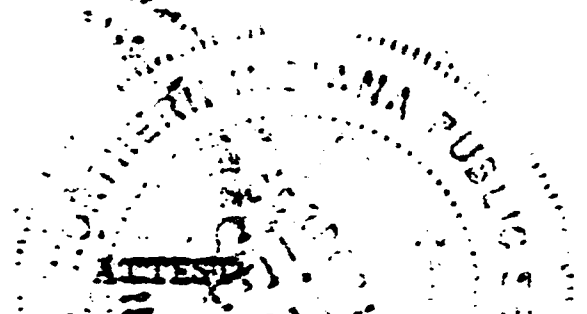
