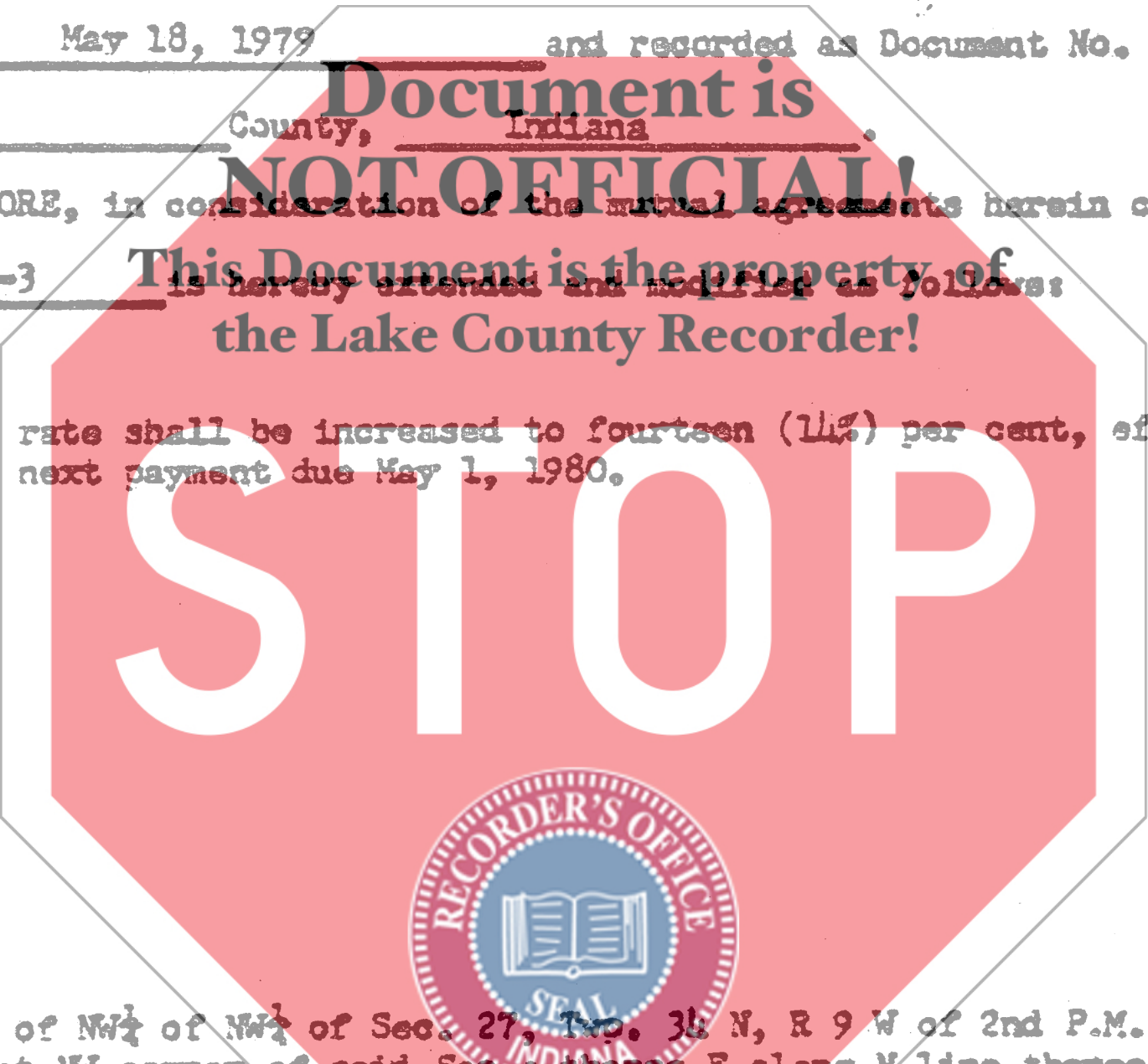

THEREFORE, in consideration of the mutual agreements herein contained, mortgage note # 170217-3 is hereby extended and modified as follows: the Lake County Recorder!

1. Interest rate shall be increased to fourteen (14%) per cent, effective with the next payment due May 1, 1980.
