Meridian, in Lake County, Indiana, more particularly des-  
cribed as follows: Commencing at a point 300 feet East  
of the Southwest corner thereof; thence extending North  
73 feet; thence West 125 feet; thence South 73 feet;  
thence East 125 feet to the place of beginning, except 30  
feet off the entire South side thereof.

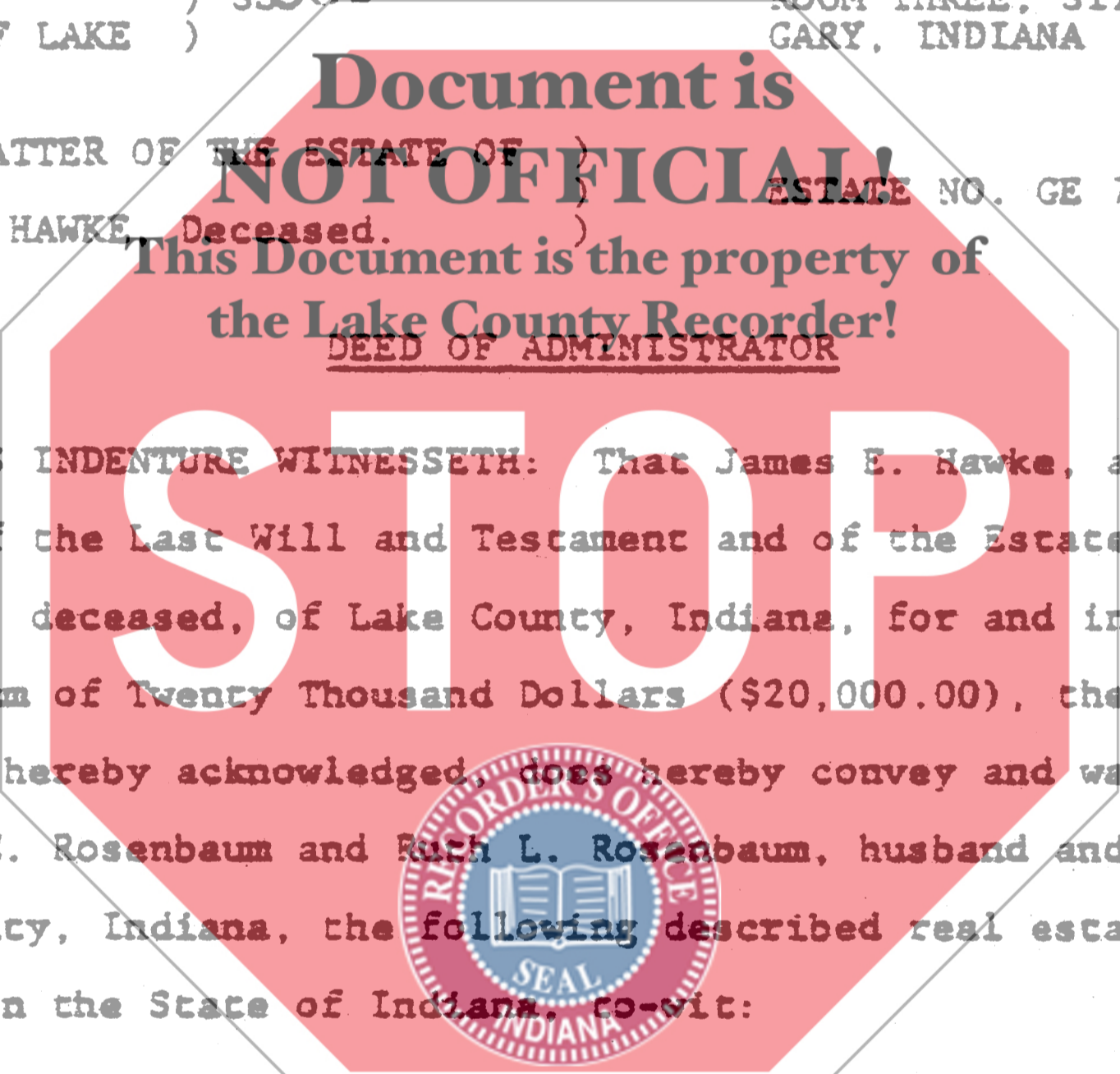
