RELEASE OF ASSIGNMENT OF CONTRACT  
(RELATING TO CONTRACT FOR PURCHASE  
OF REAL ESTATE)

KNOW ALL MEN BY THESE PRESENTS, that Calumet National Bank, a national banking association ("Assignee"), for valuable consideration and in exchange of Assignor's substitution of the proceeds from the sale of a certain parcel of real estate, which is commonly known as 8225 Columbia Avenue, Munster, Indiana, the terms and conditions of which are more fully described in a certain Contract for Purchase of Real Estate by and between The Salvation Army, as Purchaser and the St. Paul's Evangelical Lutheran Church of Hammond, Inc., as Seller, under date of March 22, 1979, and the investment of those proceeds by the Calumet National Bank in any investment agreed upon by Assignor and Assignee, does hereby Remise and Release unto St. Paul's Evangelical Lutheran Church of Hammond, Inc. ("Assignor"), all of the right, title, and interest it may have acquired in and to a certain Contract for Purchase of Real Estate, originally made between St. Paul's Evangelical Lutheran Church of Hammond, Inc., as Seller and The Salvation Army, as Buyer, dated March 22, 1979, for conveyance of the following described real estate located in Munster, Lake County, Indiana; to-wit: (H.I.)

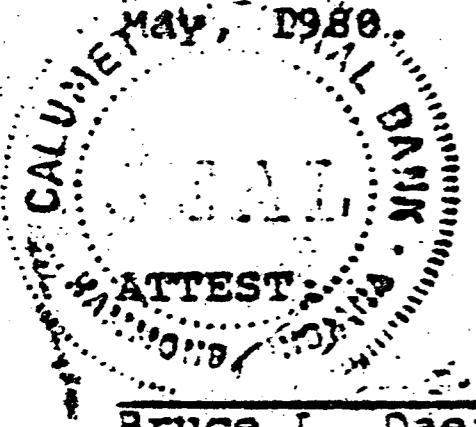
Part of the West Half of the Northeast Quarter of Section 19, Township 36 North, Range 9 West of the 2nd Principal Meridian, commencing at a point on the West line of said tract which is 1479.48 feet North of the Southwest corner thereof and running thence East at right angle 528.83 feet to the East line of the West 32 rods of said tract, thence North 0 degrees 4 minutes East on said line 288.20 feet; thence West 529.19 feet to a point on the West line of said tract which is 288.20 feet North of the place of beginning, thence South 288.20 feet to the place of beginning, excepting therefrom the following: Commencing at a point which is 322.0 feet East at right angle from a point which is 1479.48 feet North of the Southwest corner of said Northeast Quarter of Section 19; thence East 206.83 feet to the East line of the West 32 rods of said tract; thence North 0 degrees 4 minutes East on said East line of West 32 rods of said tract, 288.2 feet; thence West 206.4 feet; thence South 288.2 feet to the place of beginning, in the Town of Munster, Lake County, Indiana;
