AFFIDAVIT OF HEIRSHIP

Comes now Olga Jakush and after first being duly sworn upon oath deposes and says:

1. That she is the daughter of Mike Jakush and Elizabeth Jakush; that Elizabeth Jakush died on the 20th day of August, 1940 married to and living with Mike Jakush; that Mike Jakush died, a widower and not remarried, on the 8th day of December, 1962; that no estate was probated for either of them and that no Federal Estate Tax was due as a result of their death; that Mike Jakush left a Last Will and Testament dated November 30, 1962, but that said Will was never offered for probate.
2. That in the year 1921 or 1922 Mike and Elizabeth Jakush acquired real estate at what is commonly known as 3719 Parrish Avenue, East Chicago, Indiana, 46312, and what is legally described as follows:

  - (b) John Jakush, who died intestate on June 26, 1976, and married to Mamie Jakush, leaving as issue one son, Robert Jakush, whose address is P.O. Box 1503, Highland, Indiana 46322.
  - (c) William Jackush (sic), a bachelor and never married, who died intestate and without issue on November 4, 1964.
  - (d) Edward Jackush (sic), a bachelor and never married, who died intestate and without issue on September 30, 1965.
  - (e) George Jakush, a bachelor and never married, who died intestate and without issue on February 24, 1980.
  - (f) Amelia Jakush Salles, who is married to Herbert Salles, whose address is P.O. Box 34, Avoca, Arkansas, 72711.
  - (g) Olga Jakush, (the affiant herein) a spinster and never married, whose address is 3719 Parrish Avenue, East Chicago, Indiana 46312.
