WHEREAS, the above named and bounden Richard G. Abel has been duly elected and commissioned or appointed Treasurer, Northwest Indiana Public School Study Council in and for Lake County, in the State of Indiana, aforesaid, for the term beginning from the 1st day of July A. D. 19 80 and until his successor is duly qualified.

Now, if the said Richard G.
