to: (1) Affirm this order; (2) Rescind this order; or (3) modify this order.

If this order is not complied with, the Unsafe Euilding Department may take necessary action to enforce this order in accordance with the terms of the Unsafe Buildings Ordinance of the Town of Cedar Lake. Said action can include, but is not limited to, the Unsafe Building Department acting by and through its agents, having the work performed by means of its own workmen and equipment owned or leased by it. All costs incurred by the Unsafe Building Department will, after a hearing, be placed as a lien against said premises.

You are further informed that section 14 of the Unsafe Building Ordinance of the Town of Cedar Lake creates an obligation on you to inform subsequent interest holders of the order issued in relation to said premises and to notify the Unsafe Building Department of transfer or disposal of said unsafe premises. Full information required of Section 14 of the Unsafe Building Ordinance of the Town of Cedar Lake can be obtained at the Cedar Lake Town Hall.

A demolition permit must be obtained from the Planning and Zoning, Building and Inspection Department of the Town of Cedar Lake, Indiana, when demolishing any structure.
