AMENDED FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

This cause, coming on to be heard, the Court finding that the actual provision in the Final Judgment of Dissolution of Marriage providing for child support to the wife being incorrect, and finding that the correct amount of child support to be provided in paragraph three of the Final Judgment of Dissolution of Marriage should be \$60.00 per week, and that all of the other provisions of said paragraph and the Final Judgment of Dissolution of Marriage are correct; now, therefore it is

ORDERED AND ADJUDGED as follows:

1. That the Final Judgment of Dissolution of Marriage is entered in this cause on April 15, 1976, be and the same is hereby amended so that paragraph three shall read as follows: "The husband shall pay to the wife as permanent child support the sum of Sixty Dollars (\$60.00) per week, commencing Friday, April 16, 1976, such child support to be divided equally between the two minor children of the parties. The husband shall continue to pay such child support to the minor child, Kevin, so long as he remains disabled, or so long as is needed for him to complete a high school education prior to his becoming twenty-one years of age. Payments shall be made directly to the clerk of the circuit court."

2. That said amendment shall be a nunc pro tunc amendment, the same as if this Court had entered the same on April 15, 1976.

FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

This cause coming on to be heard on final hearing, and the Court determining that proper service of process has been had upon respondent-husband and that a default has been properly entered herein, upon the evidence it is,

ORDERED AND ADJUDGED as follows:

1. The marriage of the parties be and it is hereby dissolved because the marriage is irretrievably broken.

2. The permanent care, custody and control of the minor children of the parties shall be with the petitioner-wife, subject to the right of reasonable visitation afforded to the husband.

3. The husband shall pay to the wife as permanent child support the sum of One Hundred and Twenty Dollars (\$120.00) per week, commencing Friday, April 16, 1976, such child support to be divided equally between the two minor children of the parties. The husband shall continue to pay such child support to the minor child, Kevin, so long as he remains disabled, or so long as is needed for him to complete a high school education prior to his becoming twenty-one years of age. Payments shall be made directly to the clerk of the circuit court.

4. The husband shall save the wife harmless and indemnify her from bills or obligations incurred during the marriage, specifically to include the loan made by the wife's father to the parties, and the outstanding balances on department store accounts to Sears and Grants.

5. The wife shall be awarded as lump sum alimony the payments on the second mortgage owned by the parties in the amount of Fifty Dollars (\$50.00) per month, and the husband is specifically directed to forward all such payments which he might receive to the wife, and such payments shall accrue exclusively to the benefit of the wife.

6. The husband shall pay to the attorney for the wife, Roderic G. Magie, an attorney's fee of Three Hundred Dollars (\$300.00), plus Forty One Dollars (\$41.00) Court Costs, for a total of Three Hundred Forty One Dollars (\$341.00) payable within thirty days from this date.
