ORDER ON REVIEW HEARING

Comes now Porter County Department of Public Welfare by Gregory Hagan, its attorney, and comes now Shultz Lewis Child and Family Services, Inc. by their representatives Roger [redacted] and Jerry Montgomery, and comes natural father Roy Cheek in Court in person and comes now natural mother Marie Cheek in Review Hearing.

Witnesses sworn, evidence heard and concluded, Court now finds that since Robert Cheek and Brian Cheek have been placed in the care, custody and control of Shultz Lewis Child and Family Services, Inc. that the natural mother Marie Cheek has not exercised regular visitation rights with said children. Court further finds that that the natural father Roy Cheek has not exercised reasonable visitation with said children although such visitation is in the best interests of said children and further that on those occasions when Roy Cheek has exercised his visitation, he has been disruptive, belligerent and unreasonable in his attitudes and demands with the representatives of Shultz Lewis Child and Family Services, Inc.

Further, the Court finds that Roy Cheek is in contempt of the order of this Court dated May 11, 1979 in that he has failed to pay support to Porter County Clerk in the amount of One Hundred Twenty-five Dollars (\$125.00) payable on the fifteenth and the first day of each month, and further he is contempt of the order of this Court by failing to pay through the Office of this Court ninety (90) days after said order the four support

payments that he was in arrears.

It is therefore ordered and found by this Court as follows:

1. Roy Cheek is in contempt of the orders of this Court for failure to pay support and pay for continued support of said children as ordered by this Court May 11, 1979 although being financially able to do so.

2. It is further ordered that Roy Cheek shall immediately begin paying the sum of \$25.000 beginning the first day of October 1980 and the 15th day of October, 1980, and the 1st and 15th of each and every month thereafter until further order by this Court. It is further found that as of the date of this order Roy Cheek is arrears in his payment to the Porter County Clerk in the sum of \$4,000 which amount hereby constitutes a judgment against Roy Cheek; the attorney for the Department of Public Welfare is hereby ordered to record a copy of this judgment with the Recorder's Office in Lake County, State of Indiana, so that said judgment will constitute a lien upon any real estate owned by Roy Cheek.

3. It is further ordered by this Court that the natural mother and the natural father of said children shall exercise their visitation rights with said children as often as representatives of Shultz Lewis Child and Family Services, Inc. feels they should consistent with the best interests of the children.

4. It is further ordered by this Court that Brian Cheek and Robert Cheek remain in the care, custody, and control for placement purposes by the Shultz Lewis Child and Family Services, Inc.

5. It is further ordered by this Court that both natural mother and natural father of said children begin immediate family counseling at Porter-Starke Services at their expense, which counseling shall occur as often as the representatives of Porter-Starke Services feel such counseling should occur.

6. It is further ordered that representatives of Porter Starke Services shall forward to this Court on a monthly basis the results and report of any such counseling sessions.

7. It is further ordered by this Court that this matter be set for review hearing at 1:00 p.m. January 9, 1981 with all those in attendance at the September 26, 1980 being ordered to be present at the January 9, 1981 hearing.
