The Mortgagors expressly covenant and agree (1) to pay all taxes and special assessments levied against said real estate and improvements as the same become due and payable; (2) to keep all improvements located upon said real estate or hereafter located thereon insured against loss or damage by fire or such other events as the Mortgagee may require with insurers approved by the Mortgagee, with suitable loss payable clauses to said Mortgagee; (3) to permit no waste to be committed upon said premises or allow said premises to be used for any unlawful purposes; (4) to keep and maintain said premises in good condition and repair; and (5) in the event of the failure of the Mortgagors to keep these covenants, or any pare thereof, the Mortgagoe may pay such taxes and assessments, procure such insurance or make such necessary repairs and any sums so expended by said Mortgagoe therefor, together with interest as aforesaid, shall be and become a part of the debt secured by this mortgage.

In the event of any default in the payment of said note or the covenants of this mortgage, the Mortgages may declare the entire debt due and foreclose said mortgage, and in such event the Mortgagors shall pay all costs of said foreclosure, including the cost of securing current title data, and in such event the Mortgages is hereby given the right to obtain the appointment of a Receiver, who shall take presentation of said real estate under the usual powers and authority granted Receivers in such cases.

The Mortgagors shall make no material alterations to said real estate or remove any unprovements therefrom without the written consent of the Mortgagos, and shall not permit or suffer any legal proceedings to be instituted against said real estate; and it is further understood and agreed that this mortgage is made subject to all regulations and Sy-Laws of the said Mortgagos, which are hereby ratified and made a part of this contract, and all amendments thereto that may be made before the payment of this loan.

This mortgage shall secure the payment of any additional notes or loans made by the Mortgages to the Mortgagors at any time becaution that the discretion of the Mortgages, PROVIDED ONLY that the aggregate of the principal amount of indebtedness secured thereby, shall at no time exceed the original amount bereof.

The Mortgagers agree to reimburse the Mortgages, by means of additions to the mortgage loan balance, for all expenses caused Mortgages in connection with litigation, servicing, consultations, services, and documentation decreasery and resulting from borrowers alleged acts of omission or commission.

The Mortgagors agree not to sell or convey the mortgaged premises, without the consent of the Mortgaged, so long as any part of this dust remains unpaid, and that the violation of this provision will accelerate the manurity of the debt and cause the entire unpaid balance of the debt to become immediately due and payable, at the opnion of the Mortgages, without notice, and shall be a ground for toreclosure.
