Residential Apartment Unit 3J, together with an undivided 3.777 percent interest in the common areas of Saric Court Condominiums, a Horizontal Property Regime formed under the Statutes of the State of Indiana, and recorded as Doc. No. 529765 under date of May 22, 1979, of the Records of Lake County, Indiana, as shown in Plat Book 50, page 65, and re-recorded in Plat Book 50 Page 34, in Lake County, Indiana, together with the benefit of all rights and appurtenances created and derived therefrom.

Subject to the following: (a) all terms, conditions, uses, easements, powers, restrictions, and other covenants and provisions of the Declaration of Condominium and attached documents, including the By-Laws and Rules and Regulations of Saric Court Condominiums, and which constitute covenants running with the land; (b) restrictions in said Declaration of Condominium as to use and enjoyment as to said unit or units, which shall be used for residential purposes only; (c) taxes for the year 19 80, and subsequent years; (d) unpaid assessments of the Owners Association, Saric Court Condominiums, for the year 19 80, and subsequent years.
