Subject also to all liens, easements and restrictions of record filed prior to January 28, 1980.

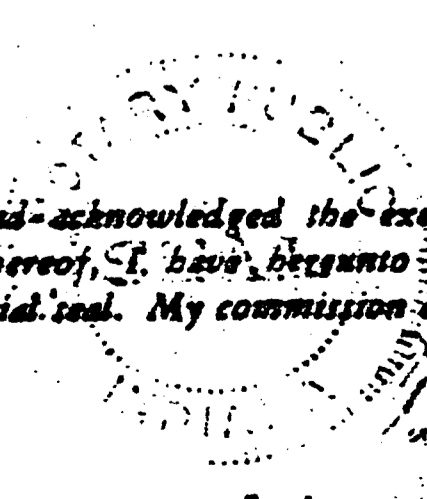
