Of that part of the East Half of the Southeast Quarter of Section 15, Township 35 North, Range 9 West of the 2nd P.M., described as follows: Beginning at a point 216.53 feet west of the Southeast corner of said Section 15, thence West on the south line thereof 292.62 feet, thence North to a point on the Southwesterly right of way of the Chicago Cincinnati and St. Louis Railroad, which point is 421.05 feet Northwesterly of the place of beginning, a distance of 297.74 feet, thence Southeasterly along said Railroad right of way 421.05 feet to the place of beginning, (except that part on the South thereof taken for 177th Street) in Lake County, Indiana, containing 1 acre more or less.
