And the Court having examined said petition and being duly advised in the premises now finds that notice was duly given and served by the Clerk on the following persons: Carrie M. Boyd and Enola M. Boyd, who are residents of the State of Indiana by certified mail with return receipt requested, posted at least fourteen (14) days prior to the date heretofore set for the hearing on such petition and notice was duly given to all unknown heirs of such decedent by publication once each week for three (3) weeks consecutively, the first day of such publication being at least thirty (30) days prior to the date set for the hearing, all as required by law and by the prior order of this Court in this proceeding.

The Court further finds that no answer or objections to such petition has been filed and that it is now properly before the Court for hearing thereon and determination thereof, and that said petitioner appeared in person and by counsel, KATZ, BRENMAN'S ANGEL, and the Court having heard and considered the visioner and being fully advised, now finds that the decedent william Boyd, Jr., died intestate on or about the 26th day February, 1978, and that at the time of his death, the decedent was domiciled in Lake County, Indiana, and left surviving him the following heirs at law:

and that the decedent's surviving spouse, Carrie M. Boyd, paid all debts of the decedent, excluding the mortgage balance due on the decedent's real estate, totalling Ten Thousand Five Hundred Ninety seven and 83/100 (\$10,597.83) Dollars and is entitled to a survivor's allowance pursuant to I.C., 29-1-4-1 in the amount of Eight Thousand Five Hundred (\$8,500.00) Dollars plus Ten Thousand Five Hundred Ninety seven and 83/100 (\$10,597.83) Dollars representing debts of the decedent paid by said surviving spouse and that said surviving spouse should receive said amounts by receiving the decedent's personal property valued at One Thousand Two Hundred Fifty (\$1,250.00) Dollars and a lien on the decedent's real estate in the amount of Seventeen Thousand Eight Hundred Forty seven and 83/100 (\$17,847.83) Dollars.
