

R 9 W of the 2nd P.M., excepting therefrom 6 acres, lying South and East of Lateral No. 9 of Beaver Dam Ditch, in Lake County, Indiana, more particularly described as part of the W 1 of the SE 1 of Section 2, T 34 N, R 9 W of the 2nd P.M., Lake County, Indiana. described as beginning at the SW corner of said SE 1; thence N 00° 04' 09" W along the West line of said SE 1, 2646.88 feet to the NW corner of said SE 1; thence S 390 28' 09" E along the North line of said SE 1, 1328.79 feet to the NE corner of said W 1; thence S 00° 02' 04" E along the E line of said W 1 2326.43 feet to the centerline of Beaver Dam Ditch Lateral No. 9; thence N 810 57' 54" W along said centerline, 573.00 feet; thence continuing along said centerline, Southwesterly, along a circular curve which is convex to the NW whose radius = 90.00 feet, tangent = 90.00 feet, deflection angle = 900 a distance of 141.37 feet along said curve; thence continuing along said centerline S 080 02' 06" W, 323.00 feet to the South line of said SE 1; thence N 890 14' 21" W along said South line, 612.77 feet to the point of beginning; containing 75.00 acres, more or less, recorded as Green Acres Estates, as per plat thereof recorded in book 51, page 25, and per plat of correction thereof recorded in book 51, page 63, in the Recorder's Office of Lake County, Indiana, EXCLUDING THEREFROM, Lots 2, 29, and 37.
