Power of Attorney

Know All Men by These Presents, That I, MARY KERN, a widow,
of Oakland County, Michigan,

have made, constituted and appointed, and by these presents do make, constitute
and appoint PAULA J. MACHNIK true and lawful Attorney for

for the purpose of managing, controlling, and operating by building and

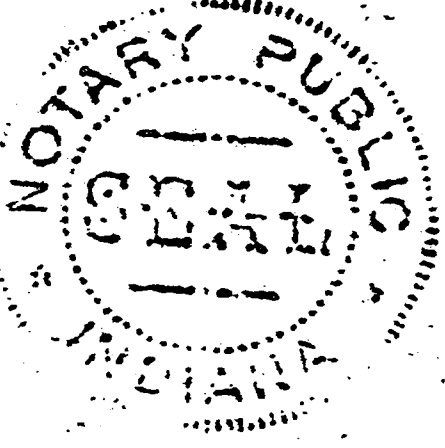
