and State of Indiana to wit:

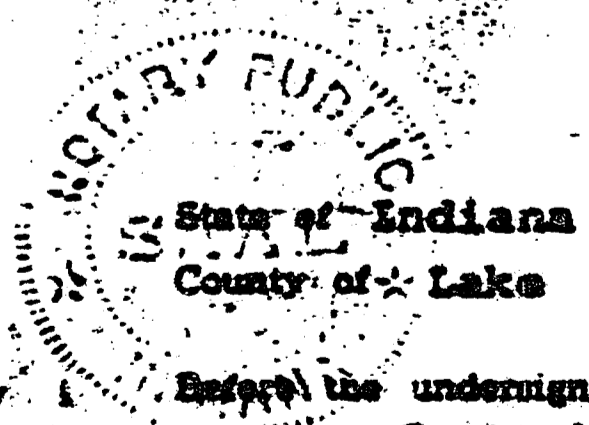
