WITNESSETH, that Mortgagor, mortgage and warrant to Mortgagee, the following described Real Estate in the County of Lake

State of Indiana, to wit:

Lot 23 in Block 2 in Evergreen Park, in the City of Hammond, as per plat thereof, recorder in Plat Book 28 page 81 in the Office of the Recorder of Lake County, Indiana

together with all buildings and improvements now or hereafter erected thereon and all screens, curtains, shades, storm mats and blinds, and heating, lighting, plumbing, gas, electric, ventilating, refrigerating and air-conditioning equipment used in connection therewith, all of which, for the purpose of this Mortgage, shall be deemed fixtures and subject to the lien hereof, and the hereditaments and appurtenances pertaining to the property above described, all of which is referred to hereinafter as the "premises".

FOR THE PURPOSE OF SECURING: (1) Performance of each agreement of Mortgagor contained herein; (2) Payment of the principal sum with interest, as provided in accordance with the terms and provisions of a Loan Agreement/Promissory Note (hereinafter referred to as "Loan Agreement") dated 10-17-80, between executed by Mortgagor and payable to the order of Mortgagee, in the principal sum of \$ 10752.78, and having the date of its final payment due on 10-24-87, or as extended, deferred or rescheduled by request or otherwise; (3) Payment of any additional advances, with interest thereon, as may hereafter be issued by Mortgagee to Mortgagor in a maximum sum of \$ 18984.00; (4) The payment of any money that may be advanced by the Mortgagee to Mortgagee for any reason or to third parties, with interest thereon, where the amounts are advanced to protect the security or in accordance with the covenants of this Mortgage; (5) Any renewal, refinancing or extension of said Loan Agreement, or any other agreement to pay which may be substituted therefor; (6) Any sums expended by mortgagee for attorney's fees and/or foreclosure expenses which are chargeable to the mortgagor under the provisions of this mortgage and/or the Loan Agreement.

All payments made by Mortgagee on the obligation secured by this Mortgage shall be applied in the following order:

FIRST: To the payment of taxes and assessments that may be levied and accrued against said premises, insurance premiums, repairs, and all other charges and expenses agreed to be paid by the Mortgagee.

SECOND: To the payment of interest due on said loan.

THIRD: To the payment of principal.

TO PROTECT THE SECURITY HEREOP, MORTGAGOR(S) AGREES: (1) To keep said premises insured for the protection of Mortgagee in such manner, in such amounts, and in such companies as Mortgagee may from time to time approve, and to keep the policies therefor, property uninsured, or deposit with Mortgagee; and that loss proceeds (less expense of collection) shall, at Mortgagee's option, be applied on said improvements, whether due or not, or to the restoration of said improvement. (2) To pay all taxes and special assessments of any kind that have been or may be levied or assessed within the State of Indiana upon said premises, or any part thereof, or upon the Loan Agreement or debt secured hereby, or upon the amount of Mortgagee in said premises or in said Loan Agreement or said debt, and procure and deliver to Mortgagee ten days before the day fixed by law for the first instant or penalty to accrue thereon, the official receipt of the proper officer showing payment of all such taxes and assessments. (3) To keep said premises free from all prior liens except the existing first mortgage, if any, and upon demand of Mortgagee to pay and procure release of any lien which in any way may impair the security of this mortgage. (4) In the event of default by Mortgagor(s) under paragraphs 1, 2 or 3 above, Mortgagee, at its option (whether electing to declare the whole indebtedness hereby secured due and collectible or not), may (a) offset the amounts above provided for and pay the reasonable premises and charges thereon; (b) pay all said taxes and assessments without determining the validity thereof (unless Mortgagor(s) have indicated proper legal proceedings to test the validity of such taxes or assessments and have deposited with Mortgagee security therefor comparable to it); and (c) pay such taxes and all such assessments, with interest thereon from the time of payment, at the highest rate allowed by law, shall be deemed a part of the indebtedness secured by the mortgage and shall be immediately due and payable by Mortgagor(s) to Mortgagee. (5) To keep the buildings and other improvements now or hereafter erected in good condition and repair, not to commit or suffer any waste or any use of said premises contrary to restrictions of record or contrary to law, ordinances or regulations of proper public authority, not to remodel the improvements except with the written consent of Mortgagee, and to permit Mortgagee to enter at all reasonable times for the purpose of inspecting the premises. (6) That they will pay, promptly and without relief from valuation or appraisement here, the indebtedness hereby secured, in full compliance with the terms of said Loan Agreement and this mortgage; (7) That the time of payment of the indebtedness hereby secured, or of any portion thereof, may be extended or renewed, and any portions of the premises herein described may, without notice, be released from the law hereby, without releasing or affecting the personal liability of any person or corporation for the payment of said indebtedness or the law of this instrument upon the remainder of said premises for the full amount of said indebtedness then remaining unpaid. (8) No change in the ownership of said premises shall release, reduce or otherwise affect any such personal liability or the law hereby created. (9) If any of the undersigned is a married woman, she represents and warrants that this instrument has been executed in her behalf, and for her acts and expenses on her behalf and that she has not executed the same as trustee for another, but that she is the true owner hereunder.

IT IS MUTUALLY AGREED THAT: (1) If the Mortgagor shall fail or neglect to pay installments on said Promissory Note or on any other advance or obligation which may be incurred hereby as the same may hereafter become due, upon commencement of any proceeding to enforce or foreclose this mortgage, or at any time thereafter until expiration of the period of redemption, Mortgagee shall be entitled as a matter of right, without notice to Mortgagor(s) or any person claiming under them, without regard to the solventy or insolvency of persons liable for the payment of the indebtedness hereby secured, without regard to the then value of the premises and the adequacy of the security, and whether or not the same shall then be occupied by the owner of the equity of redemption, to the immediate appointment of a trustee with power to take possession of said premises, to collect all rents and profits thereof and to hold and apply the receipts as the court may order for the benefit of Mortgagee and the maintenance of the security. (2) As additional security for the repayment of the indebtedness hereby secured, Mortgagor(s) hereby assign to Mortgagee all their right, title and interest in and to any existing leases and all future leases, including any oil, gas or mineral leases covering all or any part of the premises herein described and any extensions or renewals of said leases, and all rents, royalties, issues, income and profits thereof, and Mortgagee is hereby granted the right, in the event of default, to enter and take possession of the mortgaged premises and to collect such rents, royalties, issues, income and profits. Mortgagor(s) hereby authorizes and instruct the lessee under any such lease, or his or its assigns or successors in interest, to pay to Mortgagee all rents, delay rents, royalties or income that may be due or become due under any such lease or by reason of such occupancy. (3) Mortgagee shall be authorized to the time of any and all prior encumbrances, liens or charges paid and discharged from the proceeds of the Loan Agreement hereby secured, and even though said prior liens have been released of record, the repayment of said Loan Agreement shall be secured by such liens on the portions of said premises affected thereby to the extent of such payments, respectively. (4) Whichever by the terms of this instrument or of said Loan Agreement Mortgagee is given any option, such option may be exercised when the right occurs, or at any time thereafter. (5) All Mortgagor(s) shall be jointly and severally liable for fulfillment of their covenants and agreements herein contained, and all provisions of this mortgage shall have to and be binding upon the heirs, executors, administrators, successors, grantees, lessees and assigns of the parties hereto, respectively. (6) Notwithstanding anything in this mortgage or the Loan Agreement secured hereby to the contrary, neither this mortgage nor said Loan Agreement shall be deemed to impose on the Mortgagor(s) any obligation of payment, except to the extent that the same may be legally enforceable; and any provision to the contrary shall be of no force or effect. (7) Any award of damages under condemnation for injury to, or taking of, any part or all of said property is hereby assigned to Mortgagee with authority to apply or retain the moneys received, as above provided for insurance loss proceeds. (8) In case default shall be made in the payment of any installment of said Loan Agreement or of interest thereon when due or if there shall be a failure on the part of mortgagor to comply with any covenant, condition or provision of this mortgage, then the said Loan Agreement and the whole indebtedness, less accrued charges if any, secured by this mortgage, including all payments for taxes, assessments, insurance premiums, and rents, as herein specified shall, at the option of mortgagee and without notice to mortgagor (such notice being hereby expressly waived), be deemed to have accrued and become due and payable at once, or at any time thereafter at mortgagor's option, by foreclosure or otherwise. In the event of such default, mortgagor agrees to pay mortgagee's reasonable attorney's fees and/or foreclosure costs actually incurred, except to the extent that the payment of such costs by the mortgagee shall be prohibited or limited by the provisions of the Indiana Uniform Consumer Credit Code.
