ARTICLES OF INCORPORATION

The undersigned incorporator or incorporators, desiring to form a corporation (hereinafter referred to as the "Corporation") pursuant to the provisions of the Indiana General Corporation Act (Medical Professional Corporation Act/Dental Professional Corporation Act/Professional Corporation Act of 1965), as amended (hereinafter referred as the "Act",) execute the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation is REINER ROLLER RINK, INC.

ARTICLE II

PURPOSES

The purposes for which the Corporation is formed are:

- L. To hold, own, lease, manage, operate, handle, supervise or deal with roller rinks, cafeterias, cigar stands, lunch rooms, soda fountains, soft drink establishments, the renting of roller skates, the sale of roller skates and all incidentals connected therewith or in anywise related thereto; to hold, own, or operate such municipal, state or governmental licenses as may be necessary for the proper conduct of any of the businesses in which the corporation may engage; to manage, own or supervise any and all forms of legitimate indoor or outdoor amusements, roller skating events, sports, entertainments, athletic exhibitions, or similar enterprises.
- 2. To manufacture, purchase or otherwise acquire, hold, own, mortgage or otherwise lien, pledge, lease, sell, repair, maintain, service, store, assign, exchange, transfer or in any manner dispose of, invest, deal and trade in and with goods, weres, merchandise and

personal property of any and every class and description:

- 3. To purchase, take, hold, own, mortgage or otherwise lien, lease, sell, assign, exchange, convey, transfer or in any manner what-ever deal in and dispose of real property;
- 4. To acquire the good will, rights and property and to undertake the whole or any part of the assets and liabilities of any person, firm, association or corporation; to pay for the same in cash, stock of the Corporation, bonds or otherwise; to hold or in any manner dispose of the whole or any part of the property so purchased; to conduct in any lawful manner the whole or any part of any business so a acquired and to exercise all the powers necessary or convenient in and about the conduct and management of such business;
- 5. To purchase or otherwise acquire, apply for, register, hold, use, sell or in any manner dispose of and grant lécense or other rights in and in any manner deal with patents, inventions, improvements, p processes, formulas, trademarks, trade names, rights and licenses secured under letters patent, copyrights or otherwise;
- 6. And to engage in allied and interdependent lines of business; provided, however, that the powers herein enumerated shall not be construed as a limitation on the powers or rights of the Corporation; and the powers enumerated herein shall not be construed as a limitation upon the business to be conducted by the Corporation, and the Corporation shall have all other powers and authorities granted to it by the laws of the State of Indians.
