MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE, made this 16th day of September, 1980, by and between Ant-Lor, A Limited Partnership, LESSOR, and American Security Corporation No. 5, LESSEE.

WITNESSETH

WHEREAS, The undersigned Lessor is now the Landlord, and the undersigned Tenant is now the Lessee under that certain Lease Agreement dated November 2, 1977, by and between Cav-Nan Enterprises duly assigned to Ant-Lor, LESSOR, and American Security Corporation No. 5, LESSEE,

and the parties hereto as the present Lessor and present Lessee, respectively, desire by this Agreement to comply with the provisions of said Lease relating to the execution and recordation of a Memorandum of Lease:

NOW, THEREFORE, in consideration of the premises and the mutual agreement of the parties hereto herein contained, the parties hereto acknowledge and agree as follows:

1. That possession of the leased premises was delivered to the Lessee under said Lease on or about December 1, 1977.
2. That the term of said Lease commenced on December 1, 1977, and will terminate on November 30, 1983; there is an option entered for Three (3) years.
