ORDER APPROVING FINAL REPORT  
AND ACCOUNTING, PETITION TO ALLOW ACCOUNTING, AND PETITION  
FOR ORDER APPROVING DISTRIBUTION  
AND CLOSE ESTATE

This cause came to be heard on the 9th day of December, 1980 upon the final account, petition to settle and allow account and authority to distribute estate filed by Stella T. Balba as executrix of the estate of John Skalba, deceased, which account and petition in the words and figures following, to-wit:

And it appearing that no objections were filed thereto, the Court being fully advised in the premises now finds that:

1. Due notice of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.

2. That John Skalba, died testate, a resident of the County of Lake, State of Indiana, on the 6th day of March, 1975, and his Last Will and Testament was duly admitted to probate before this Court on the 2nd day of December, 1975, and this Court appointed said Stella T. Balba as executrix of the Last Will and Testament of the decedent, and said executrix was issued Letters Testamentary on the 2nd day of January, 1976; and since that date she has continued to serve in such capacity.

3. That said matters and things stated in said account and petition are true, and that said executrix has accounted for all the assets in said estate coming into her hands.

4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor his executrix were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. The following persons are the sole legatees and devisees under the decedent's Last Will and Testament: Stella T. Balba, and Marie Patena, and that all assets and property of this estate remaining after payment of decedent's debts and expenses of administration has been distributed to the above named persons.

6. That the decedent owned a certain piece of real estate located at 617 Hoffman St., Hammond, State of Indiana, more particularly described as follows:

Lot 7 and the West 15<sup>1</sup>/<sub>2</sub> feet of Lot 8 in Block #7 in Key# 34-108-7  
Hoffman's 2nd addition to the City of Hammond, as per  
plat thereof, recorded in Plat Book 1, Page 92, in the  
Office of the Recorder of Lake County, Indiana.

and that said real estate vested in Stella T. Balba and Marie Patena upon the death of the decedent as part of the residuary estate, and a copy of this instrument, the vesting of said real estate should be recorded in the office of the County Recorder in which said real estate is located.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final report and Account of said executrix is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said executrix's hands for distribution has been made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

3. That pursuant to the decedent's Last Will and Testament the following described real estate, to-wit:


Lot 7 and the West 15 $\frac{1}{4}$  feet of Lot 3 in Block "Y" in Hoffman's 2nd Addition to the City of Hammond, as per plat thereof, recorded in Plat Book 1, Page 98, in the Office of the Recorder of Lake County, Indiana.

is hereby vested in Stella T. Balka and Marie Patena as tenants in common pursuant to the provisions of the decedent's Last Will and Testament.

And that said executrix is hereby directed to procure and record in the office of the Recorder of Lake County, being the County in which said real estate is located, a certified copy of this Final Decree.

4. Said executrix having made distribution of all assets and property and having attached Affidavit in Lieu of Vouchers evidencing said distribution to said legatees and devisees, said distribution is hereby approved and confirmed.

5. Said executrix has in all things carried out the provisions of this final decree, and is hereby released and discharged from any further liability or responsibility along with her surety as said executrix of the estate of John Skaiba. All of which is ordered this 1 day of December, 1980.
