A RESOLUTION VACATING SUNSET
MANOR SUBDIVISION IN THE CITY
OF HOBART, INDIANA

WHEREAS, the Board of Public Works and Safety of the City of Hobart, Lake County, Indiana, desires to vacate Sunset Manor Subdivision, which is particularly described below; and

WHEREAS, the Plan Commission of the City of Hobart, on January 13, 1981, in Plan Commission Action No. 30-12 approved such vacation; and

WHEREAS, the Board of Public Works and Safety of the City of Hobart now determines that it would be in the best interest of the City of Hobart that such subdivision be vacated.

NOW, THEREFORE, be it resolved by the Board of Public Works and Safety of the City of Hobart, Lake County, Indiana, that the following described subdivision within the City of Hobart, Indiana, shall be and is hereby vacated:

- 18-214-1 Lots 1 to 20, both inclusive, in Block 1;
 - 18-215-1 Lots 1 to 22, both inclusive, in Block 2;
 - 18-216-1 Lots 1 to 15, both inclusive, in Block 3;
 - 18-217-1 Lots 1 to 12, both inclusive, in Block 4
- ENTIRE SUB VACATED TO per plat thereof, recorded in Plat Book 33 page 77, in the Office of the Recorder of Lake County, Indiana.
- (Being all of Sunset Manor Subdivision.)

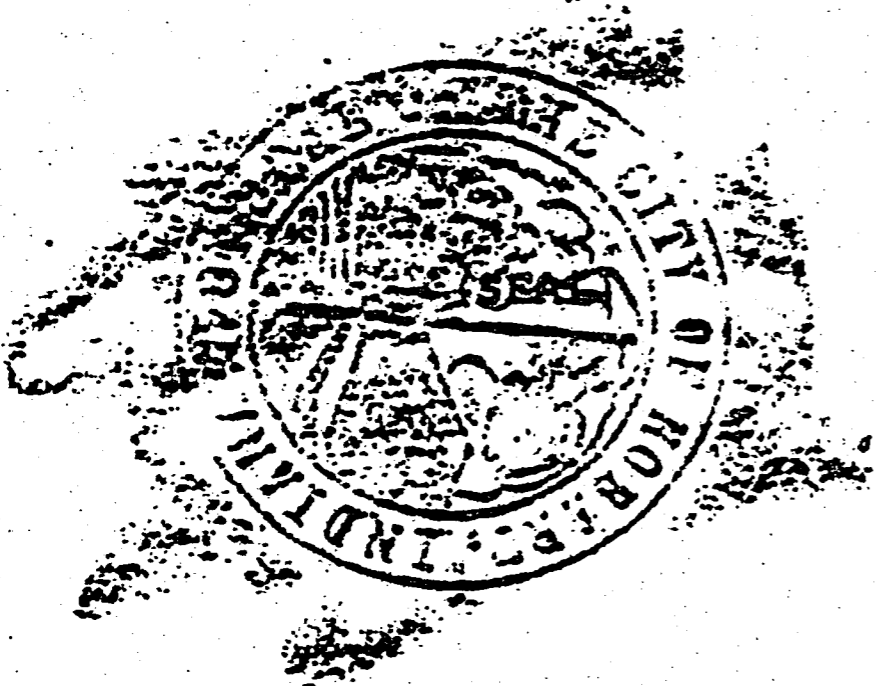
