AFFIDAVIT

We, Samuel D. Smith and Emma L. Smith, first being duly sworn upon our oath, do allege and state as follows:

1. That we are the owners of the following described real estate:

Lot Three (3) in Block Four (4) in Gary Land Company's Fifth Subdivision in the City of Gary, Lake County, Indiana, as per plat thereof, recorded in Plat Book 15, page 3-1/2 in the Office of the Recorder of Lake County, Indiana, more commonly known as 615 Rutledge Street, Gary, Indiana.

- 3. That on July 12, 1974, we signed a mortgage to American Surety Underwriters, Inc. and Teola Jackson, which mortgage was recorded on July 16, 1974, as Document No. 259512, to secure a bond for Emma L. Smith's brother, Defendant Mitchell M. Calhoun, in the United States District Court, Criminal Division, under Cause No. ECR 75-52;

- 5. That the case was appealed and said appeal was decided by the United States Court of Appeals on January 25, 1975;

That the said bonds which were secured by the second and third mortgages described in rhetorical paragraphs #2 and #3 of this affidavit on the real estate described in rhetorical paragraph #1 of this affidavit were released by the United States District Court, Criminal Division on January 27, 1975, but said release was not properly recorded;
