KNOW ALL MEN BY THESE PRESENTS:

That I, COLEMAN E. ROZSNYAI, of the
City of HOBART, County of LAKE,
and State of INDIANA, do hereby make, publish and
declare this to be my last Will and Testament, hereby revoking all former wills and codicils here-
tobefore made by me.

ARTICLE I

I hereby direct that all of my just debts, funeral expense, the expense of my last ill-
ness, and all estate and inheritance taxes which may be imposed on my estate, or on any bequest,
taxable by reason of my death, or on proceeds of policies of insurance on my life be paid by my
Executor.

ARTICLE II

I give and bequeath the following:

TO MY NATURAL SON, DUANE ROZSNYAI, I HERE BY LEAVE WHAT CERTIFICATES,
ARE IN HIS AND MY NAME ONLY, THESE ARE MONEY CERTIFICATES FROM BANK OF INDIANA,
IF THEY HAVE NOT ALREADY BEEN CASHED. I ALSO DIRECT MY STEPSON, LOY R. ROBERSON,
TO BE THE EXECUTOR OF MY ESTATE, AND TO HIM I LEAVE THE SAME AMOUNT OF MONEY
IN CERTIFICATES THAT ARE IN HIS NAME AND MINE, THESE ARE TO BE EQUAL SHARES. ALL
(LOY R. ROBERSON) (COLEMAN D. ROZSNYAI)
FURNITURE IS ALREADY MY STEPSONS, THE CAR IS ALREADY MY SONS.

I HAVE INSTRUCTED MY STEPSON LOY R. ROBERSON TO CARRY OUT MY FINAL WISHES,
AND DEMANDSAFTER MY DEATH MARY C. ROBERSON, MY DAUGHTER-IN-LAW, SHALL FULL FILL
ANY ARRANGEMENTS I HAVE REQUESTED OF HER FOR MY BURIAL, AT CALUMET PARK CEMETARY.

I AM OF SOUND MIND, AND PHYSICALLY ABLE TO MAKE THIS MY LAST WILL AND TESTAMENT.
MY HANDGUNS TO MY SON DUANE, ALL OTHER PERSONAL EFFECTS TO MY STEPSON, LOY R. ROBERSON.

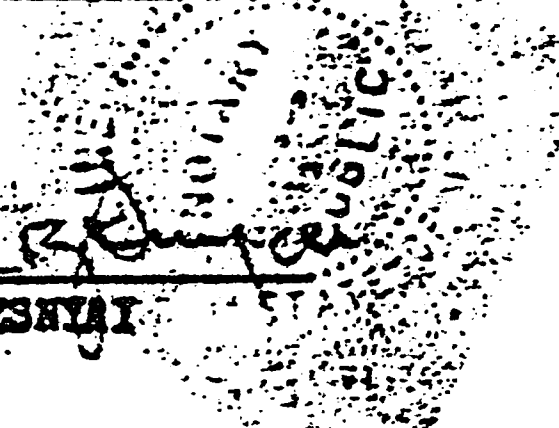
ARTICLE 3
