WHEREAS, The Lowell National Bank of Lowell, Indiana loaned George W. Boucher

3. An assignment of savings account shall be taken as security, with a hold of \$1000.00 against savings account #18-62h-7.
4. A fee of \$12.70, covering costs of this agreement including recording fees, shall be due and payable with the execution of this agreement.

All other terms of said mortgage shall remain the same.
