CANCELLATION OF CONTRACT FOR SALE OF REAL ESTATE AND RELEASE AGREEMENT

THIS AGREEMENT, made and entered into at Portage, Indiana, by and between PHONZO KIUTTS and HAZEL KLUTTS, Busband and Wife, of Lake County, Indiana, hereinafter referred to as "Purchasers", and GEORGE KAMANO and INEZ KAMANO, Husband and Wife, of Lake County, Indiana, hereinafter referred to as "Sellers".

WITHESSETH:

WHENEAS. Sellers executed a Contract for the Sale of the Following described real estate:

which contract was executed on the 27th day of August, 1980; and

WHEREAS, said Buyer is not in default under the terms of said contract; indes

WHEREAS, the parties desire to cancel the contract and release the said Buyers from any obligation to pay anything further under said contract and to give unto the said Sellers any and all rights, claims or interests that the said Buyer may have in and to said Contract for Conditional Sale of Real Estate or the real estate made the subject of said contract; and

WHEREAS, Sellers have returned \$8,000.00 to Suyers representing Buyers down payment together with Buyers out of pocket expenses incurred in moving.

NOW THEREFORE, it is hereby agreed by the parties as follows:

- 1. Buyer hereby releases, quit claims and divests themselves of any interest in and to said real estate described above, and hereby cancels, rescinds and quit claims any interest that they might have or could have under said Contract for Conditional Sale of Real Estate. The said Buyer herewith gives and quit claims any and all rights to possession of said real estate to the said Sellers, the legal owners.
- 2. The Suyers represent and warrant that they have not assigned, sold or pladged the Contract for Conditional Sale of Real Estate to any other person, nor :have they encumbered, sold or disposed of the Real Estate made the subject of said Contact.
- 3. The Sellers in consideration for the cancellation of the said Contract by the said Buyers, hereby forgive, release and quit claum any and all claims that they may or could have under said Contract for Conditional Sale of real estate against Suyers.
