hereby mortgage and warrant to the First National Bank of East Chicago, Indiana, Lake County, Indiana, the
following described property in the County of Lake and State of Indiana to wit:

Lot 9 and Lot 10 except the East 100 feet and the North 40 feet thereof in
Kuehls Acres, and shown in Plat Book 22, page 40, Lake County, Indiana;
and also a part of the NW 1/4 of the SW 1/4 of Section 21, Township 35
North, Range 8 West of the 2nd P.M., more particularly described as: Be-
ginning at the Southeast corner of said quarter-quarter section; thence West
265.96 feet along the South line of said quarter-quarter Section; thence
North to the Southwest corner of said Lot 9 in Kuehls Acres; thence East
265.96 feet along the South line of said Lots 9 and 10 in Kuehls Acres to
a point on the East line of said quarter-quarter section to the place
of beginning, excepting the East 100 feet thereof in Lake County, Indiana,
