THEREFORE, the condition of this bond is that, if said Principal shall comply with all of the conditions of the ordinances and regulations of the Oblige pertaining to said license and shall indemnify and save harmless the Oblige from all damages which the Oblige shall sustain by reason of the failure of the said Principal to comply with all of the conditions of said ordinances and regulations, then this obligation shall be null and void; otherwise to remain in full force and effect subject to the following conditions:

1. This obligation may be extended from year to year at the option of the Surety, by continuation certificate executed by the Surety.
2. This obligation may be cancelled by the Surety upon giving thirty (30) days' written notice to the Oblige. However, this obligation shall remain in full force and effect as to the acts or omissions of the above mentioned Principal prior to the cancellation of the bond.

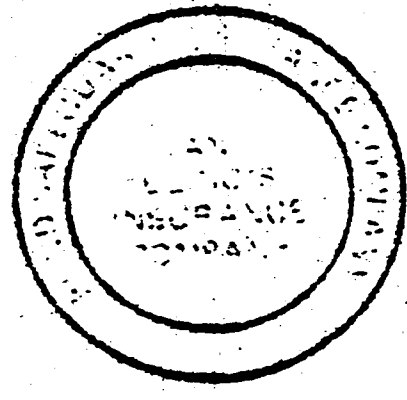
