AFFIDAVIT OF SURVIVORSHIP

Judith A. Porter Biggs, being first duly sworn upon her oath, deposes and says, to-wit:

That she now resides at 6803 Lincolnway, Hobart, Lake County, Indiana 46342, and is the surviving widow of Richard R. Porter, a/k/a Richard Ray Porter, deceased, who died on the 30th day of July, 1974, and whose record of death is duly entered in the records maintained by the Somerset Health Department, Pennsylvania State Board of Health, Division of Vital Records, Local Record No. 206836.

That this Affiant and her now deceased husband, Richard R. Porter, a/k/a Richard Ray Porter, were married subsequent to the date the decedent acquired title to the hereinafter described real estate by Deed of Conveyance dated July 21, 1955, and recorded December 19, 1955, as Document No. 893135 in Book 1017, page 349, in the Office of the Recorder of Lake County, Indiana, said real estate being described as follows, to-wit:

The West 215 feet of that part of the East One— GF KEY 12-5-36 Half of the South West Quarter (E's SWh) of Section Seventeen (17), Township Thirty-Five (35) North, GG Range Seven (7) West of the 2nd P.M., lying South of Route #330 (The Old Joliet Wagon Road), containing 3.056 acres, more or less.

That the marital relationship which existed between this Affiant and her husband, Richard R. Porter, a/k/a Richard Ray Porter, deceased, continued unbroken from the date of their marriage until the death of the said Richard R. Porter, a/k/a Richard Ray Porter, deceased, on the

30th day of July, 1974, and that the said Richard R. Porter, a/k/a Richard Ray Porter, deceased, was survived by this Affiant as his surviving wife, and survived by his daughters. Gail Elizabeth Porter and Julie Ann Porter, as his sole and only heirs at law.

That the said Richard R. Porter, a/k/a Richard Ray Porter, deceased, died intestate, and that administration of his estate has been commenced and is now pending in Cause No. CE75-206 in the Lake Circuit Court, sitting at Crown Point, Lake County, Indiana; that the gross value of the estate of the said Richard R. Porter, a/k/a Richard Ray Porter, deceased, taking into consideration in the valuation thereof the value of all of his gifts in contemplation of death, including all gifts made by him in the three years preceding his death, and the value of all of his investments and joint properties and estates by the entireties, including the real estate above described, plus the proceeds of the life insurance on his life, did not equal or exceed the sum of Sixty Thousand Dollars (\$60,000.00), as a consequence of which his estate was not subject to Federal Estate Tax. pany Division, Crown Point, Indiana, to rely hereon and in reliance hereon to issue a policy and/or policies of owner's-mortgagee's title insurance free of any objection based upon the fact of death of the said Richard R. Porter, a/k/a Richard Ray Porter, deceased.
