2. That NICK CARONE, died testate, a resident of the County of Lake, State of Indiana, on the 2nd day of June, 1980, and his Last Will and Testament was duly admitted to probate before this Court on the 24th day of June, 1980, and this Court appointed said PHYLLIS M. CARONE as executrix of the Last Will and Testament of the decedent, and said executrix was issued Letters of Testamentary on the 24th day of June, 1980, to her and since that date she has continued to serve in such capacity.
3. That the matters and things stated in said account and petition are true, and that said executrix has accounted for the assets in said estate coming into her hands.


