That part of the East 527.8 feet of the Northeast quarter of the Southwest quarter of Section 13, Township 36 North, Range 9 West of the 2nd P.M., described as follows:

Beginning at a point on the East line of the Northeast quarter of the Southwest quarter of said Section 13, 1089 feet North of the Southeast corner thereof; thence West along a line at right angles to said East line a distance of 30 feet; thence in a Southwesterly direction a distance of 382.9 feet to a point being 85 feet West of the East line of said Northeast quarter of the Southwest quarter of Section 13, measured at right angles thereto; thence West along a line perpendicular to the East line of said Northeast quarter of the Southwest quarter of Section 13 a distance of 442.77 feet to the West line of the East 527.8 feet of the Northeast quarter of the Southwest quarter of said Section 13; thence North along the West line of the East 527.9 feet of said Northeast quarter of the Southwest quarter of Section 13 a distance of 610.88 feet to the North line of the Northeast quarter of the Southwest quarter of Section 13; thence East along the North line of said Northeast quarter of the Southwest quarter a distance of 527.8 feet to the Northeast corner thereof; thence South along the East line of the Northeast quarter of the Southwest quarter of Section 13 to the point of beginning, in Lake County, Indiana.
