Access to the above described land over the existing lands of the grantor is hereby granted. Each grantee may cut or trim trees, bushes and saplings growing upon or extending over said land so far as may be reasonably necessary in the construction, operation and maintenance of said line or lines.

No buildings or trees shall be placed on said easement.

These presents to be binding on the heirs, executors, administrators, grantees and assigns of the grantor, and upon each grantee, its successors and assigns.
