And the Court finds that the real estate, to-wit:

The two story brick and stucco residence situated and known as 6630 Forest Avenue in the City of Hammond, Lake County, Indiana, being the north 120 feet of Lot 3, Block 3, South View Addition to Hammond, Indiana, together with all improvements thereon, Unit # 06 Play # 36-112-4

was devised by decedent's Will to Tora Christianson Brennan and Arnold Christianson "to have and to hold the same in joint tenancy with the provision that said beneficiaries shall provide a suitable home in said residence for my ailing daughter, Helga Christianson, with power to sell the same should circumstances in their judgment make such sale necessary, but to immediately make provisions to substitute by purchase or otherwise, a modern, suitable residence for their use and ownership and for the use of my said daughter, ~~Helga Christianson~~ her full recovery or demise, should ~~she die~~ occur." *FILED*

there be a credit difference between the sale and the purchase or the cost of construction of another building, the sum remaining shall be divided equally between Raynard Christianson, Christian Christianson, Erling Christianson, and Mary Christianson Stewart" and the Court confirms the same.

And the Court now finds that decedent's estate has been fully administered, and the Court now discharges said co-executors and releases their bond, and adjudges this estate fully administered, settled and closed.


