

Part of the Northwest 1/4 of the Northwest 1/4 of Section 14, Township 35 North, Range 9 West of the 2nd Principal Meridian, in the Town of Schererville, Lake County, Indiana, described as follows: Beginning at a point in the centerline of the Old Lincoln Highway 426.55 feet Easterly, along said centerline, from the West line of Section 14 aforesaid; thence South parallel to said section line, 243.59 feet; thence West along a line parallel to the North line of said Section 14, 250 feet; thence North parallel to West line of said Section 14, 203.25 feet to the centerline Natiof the aforesaid Highway; thence Easterly along the centerline of said Old Lincoln Highway 253.60 feet to the place of beginning; except the West 110 feet thereof, measured along the South line of said tract.
