Center of page: In Guadalajara on the 30th (thirtieth) of April in the year 1967 (nineteen sixty-seven) at 9 (nine) 15 (fifteen) before me, Carlos Casillas, Officer of the Civil Registry of this city, Martiniano Godoy, a married employee, appeared and said that yesterday at 9 (nine) o'clock at the home address of 2124 (twenty-one twenty-four) on 27th (twenty-seventh) Street of the Libertad Sector of this city, Mr. JESUS MERCADO MERCADO, a 63 (sixty-three) year old native of Cuquio, Jalisco, a neighboring city, son of José Mercado and María Guadalupe Mercado, married to María Guadalupe Reyes, died from pulmonary adenocarcinoma and pulmonary emphysema and will be buried in the Municipal Cemetery. Dr. Manuel Perez Reyes, who resides at number 46 (forty-six) on 60th (sixtieth) Street, Libertad Sector, signed the death certificate. Witnesses: Luis Bravo and Guadalupe Gutierrez, married employees who are of age and who reside at the above address. It was read and signed by one who knows the accuracy of its contents. Signed: J.
