David Pustek, Executor, respectfully represents to the Court:

1. The decedent died September 26, 1978. His Last Will and Testament dated January 30, 1978, was admitted to probate December 12, 1978. The undersigned qualified and was appointed as Executor December 12, 1978, and thereafter due notice of his appointment was published, the first publication being had in December, 1978.

2. More than five months have elapsed since the date of first notice of appointment to all heirs and creditors. Indiana Inheritance Tax has been paid in full, a copy of the countersigned receipt is attached. No Federal Estate Tax was due in this estate. All other taxes, claims, debts and expenses of administration have been paid. Neither the decedent or this Executor were employees of labor within the meaning of that term as used in the Indiana Employment Security Act.

3. All of the assets of the decedent have been administered upon and reduced to cash and no reason exists why this estate should not be closed at this time.
