PARCEL ONE

That part in the Old Survey of Section One, Township Thirty-seven North, Range Ten, West of the Second Principal Meridian, in the City of Hammond, Lake County, Indiana Described as follows, to wit: Commencing at a point on the Southwesterly Line of Indianapolis Boulevard which is Five Hundred Twentyfive Feet Northwesterly from the Intersection of the Southwesterly Line of Indianapolis Boulevard with the Westerly Line of Calumet Avenue; thence extending Northwesterly on the Southwesterly Line of Indianapolis Boulevard a distance of Seventy-five Feet more or less to a point on the Southwesterly Line of Indianapolis Boulevard, and on the Southeasterly Line of property hereafter described and designated as the Estella Schaak Tract and thence Southwesterly at Right Angles to said Indianapolis Boulevard along the Southeasterly Line of said Estella Schaak Tract a distance of One Hundred Eightythree feet to a point; thence Southeasterly on a Line Parallel to Indianapolis Boulevard a distance of Seventy-five Feet, more or less to a point One Hundred Twenty-five Feet Northwesterly from the Westerly Corner of the Land heretofore conveyed to James C.
