No memorial, tree, plant, object of embellishment of any kind shall be placed upon, altered or removed from the interment spaces without the written consent of Grantor first had and obtained; and Grantor reserves at all times the exclusive right to grade and improve all parts of said cemetery and to remove any trees or shrubbery of any kind therefrom.
3.	All rights, title and interest hereby conveyed to Grantee are and shall remain subject to the Rules and Regulations of Grantor now in effect and such reasonable amendments and additions thereto as hereinafter may be adopted by the Grantor and its successors in interest in the cemetery, for the control, regulation and management of the said cemetery, as though fully rewritten herein. A copy of the Rules and Regulations as now in effect is prominently posted at the cemetery property office.
4.	The Grantor covenants and agrees that to provide care and maintenance for the improved cemetery portions of the cemetery an Irrevocable Endowment Care Fund has heretofore been established, into which the
