Telephone Company, Incorporated, and Northern Indiana Public Service, its/their successors and assigns a right of way and easement to install, construct, operate, maintain, repair supplement and remove at anytime or times hereafter, its communications and electric systems consisting of poles, anchors, wire, conduits, manholes, cables, fixtures and equipment as it may from time to time require or deem proper therefor, in, under and upon a strip of land located in Section 4.

Also the right of ingress and egress over and across said strip and land adjacent to said strip for the purpose of exercising the rights herein granted, and to trim or cut down any trees which in the opinion of the Grantees at any time interfere or threaten to interfere with the construction and operation of said line facilities.

The Grantees agree to be responsible and pay for all damages to the Grantor's property and/or crops that have been caused by the construction and maintenance of said communication and electric systems.

The Grantor warrants that no structure or building, except fencing, driveways or streets, shall be erected upon said easement. The Grantor agrees to notify the Grantees before construction of any fences, driveways or streets is started.

The Grantor reserves, after the completion of said system the full use of the land which is not inconsistent with the existence and maintenance of said communication and electric systems but does agree to notify the Grantee of any proposed change in elevation or grade within the area of said easement.
