A RESOLUTION TO VACATE A STREET

WHEREAS, on October 14, 1981, Lake Mortgage Company, Inc., Clyde Biggs, and Helen Biggs (hereinafter, "petitioners") filed their Petition to Vacate (hereinafter, "petition") with the City Works Board, which sought the vacation of a part of Wirtz Road and a part of Monitor Street, more particularly described as follows, to-wit:

A strip of land 60 feet wide, being a part of the Southeast Quarter of Section six (6) in Township thirty four (34) North, range eight (8) West of the 2nd P.M., in Lake County, Indiana, the center line of which said strip of land is described as, commencing at a point on the North line of the Southeast Quarter of said Section 6, which point is the center point of the North line, of the East 16.94 acres of the Northeast Quarter of the Southeast Quarter of said Section 6, thence South, parallel with the East line of said Section 6, 80 rods and 30 feet, to a point 30 feet south of the South line of the Northeast Quarter of the Southeast Quarter of said Section 6, thence East, parallel with the South line of the Northeast Quarter of the Southeast Quarter of said Section 6, to the Section line between Sections 5 and 6 as recorded in Deed Record 401, Page 545.
