Also subject to any and all assessments or installments thereof due or to become due after the date of this Deed.

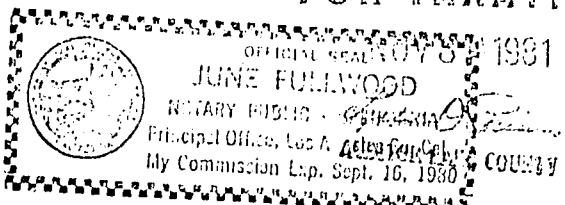
