or license and will in all things, strictly comply with the conditions of the permit or license, then this obligation is to be void, otherwise to remain in full force, virtue and effect.

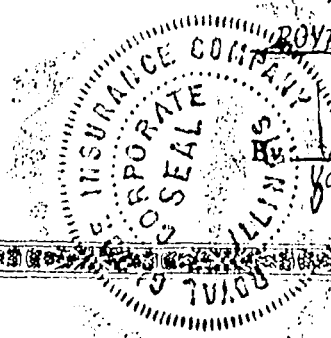
