CERTIFICATE OF LIMITED PARTNERSHIP  
AND ASSUMED NAME

WE, the undersigned, for the purpose of forming a limited partnership pursuant to the Uniform Limited Partnership Act as set forth in I.C. 23-4-2-1 et seq, hereby certify:

1. NAME. The name of the partnership is THE BUTCHER SHOP, Ltd.

2. CHARACTER OF BUSINESS. The character of the business to be carried on is to engage in the business of ownership, operation and management of meat market, delicatessen, and limited grocery.

3. PLACE OF BUSINESS. The location of the principal place of business of the partnership is 2820 Highway Avenue, Highland, Indiana 46322.

5. TERM. The term for which the partnership is to exist is indefinite.

6. INITIAL CONTRIBUTION OF EACH LIMITED PARTNER. Each limited partner contributed One Thousand Dollars (\$1,000.00).

7. ADDITIONAL CONTRIBUTIONS OF EACH LIMITED PARTNER. Each limited partner may (but shall not be obliged to) make such additional contributions to the capital of the partnership as may from time to time be agreed upon by the general partners.

8. RETURN OF CONTRIBUTION TO EACH LIMITED PARTNER. The contribution of each limited partner is to be returned to him as may from time to time be agreed upon by the general partners.

9. PROFIT SHARES OF EACH LIMITED PARTNER. The share of the profits or other compensation by way of income which each limited partner shall receive by reason of her contribution is Twenty-five per cent (25%) each.

10. ASSIGNMENT OF LIMITED PARTNER'S INTEREST. Each limited partner is given the right to substitute an assignee as contributor in his place, provided that the assignment is approved by all the general partners.

11. ADMISSION OF ADDITIONAL LIMITED PARTNERS. The general partners are given the right to admit additional limited partners, provided that the admissions are approved by all the general partners, but in no event other than upon a cash contribution to the partnership and upon the same terms as herein expressed.

12. DEATH, RETIREMENT OR INSANITY OF GENERAL PARTNER. In the event of the death, retirement or insanity of the general partner, the remaining limited partners shall have the right to continue the business of the partnership under the same name by herself or himself or in conjunction with any other persons she or he may select.

13. RIGHT OF LIMITED PARTNER TO RECEIVE PROPERTY OTHER THAN CASH. Each limited partner is given the right to demand and receive property other than cash in return for his contribution, and the value of such property shall be that shown on the books of the partnership.
