AFFIDAVIT OF SURVIVORSHIP

Richard Kaminsky, being duly sworn under oath, deposes and says: That he resides at 2107 Davis Avenue, Whiting, Indiana, and is a son of Andrew S. Kaminsky and Julia Kaminsky, who are now deceased.

That Andrew S. Kaminsky and Julia Kaminsky, his wife, acquired title some years ago to the following described real estate, to-wit:

Key 34-24528
Lot 28, Block 2, 2nd Lake Addition to Hammond, which real estate is commonly known as: 2111 Davis Avenue, Whiting P.O., Lake County, Indiana.

That at the time that the undersigned's parents acquired title to the real estate they were married to each other and continued to be married to each other continuously and without interruption until Andrew S. Kaminsky died, and he left surviving him his wife, Julia Kaminsky.

That Andrew S. Kaminsky died approximately 16 years ago, and at the time of his death he left a Last Will and Testament leaving everything to his wife, Julia Kaminsky, but it was not necessary to probate the will. Title to the above described real estate became vested, upon his death, into the name of his wife, Julia Kaminsky, who survived him.

That Julia Kaminsky still held title to the above described real estate when she died on February 14, 1981. That at the time Julia Kaminsky died, she left a Last Will and Testament, which has been admitted to probate in the Lake Superior Court, Room #2, in East Chicago, Indiana, and assigned Estate No. EE 81-134.

That the Will of Julia Kaminsky, as probated, has the following provisions therein: "I give, devise and bequeath all of my property, real, personal and mixed, whatsoever and wheresoever to my two (2) sons, namely, RICHARD KAMINSKY and A. DONALD KAMINSKY, share and share alike."

According to the terms of the above mentioned Will, title to the above described real estate is now vested in Richard Kaminsky and A. Donald Kaminsky.

That said Will also contained a provision in ITEM TWO for the payment and delivery of the sum of TWO HUNDRED FIFTY (\$250.00) DOLLARS to St. John The Baptist Parish, in Whiting, Indiana, and in compliance with said provision of the Will, the undersigned has paid the sum of \$250.00 to St. John The Baptist Parish, Whiting, Indiana, and that there is attached to this Affidavit a receipt signed by the Pastor of St. John The Baptist Parish, stating that the above sum of \$250.00 has been received. That said ITEM TWO of said Last Will and Testament has been complied with.

The undersigned further states that there is no Federal estate tax due in the above mentioned estate because the amount left by the deceased is less than the exemption to which the estate is entitled.

That the undersigned makes this affidavit for the purpose of showing that Andrew S. Kaminsky and Julia Kaminsky, owners of the above described real estate, are now deceased, and that Julia Kaminsky left a Last Will and Testament which has been admitted to probate; and that title should now be shown, as per the Will of the deceased, in the names of Richard Kaminsky and A. Donald Kaminsky; and that future tax statements should be mailed to: 2107 Davis Avenue, Whiting, Indiana 46394.
